2. **Safety Equipment:** I agree to wear appropriate safety equipment provided by Our Red Barn Ranch, LLC during all horseback riding activities, including but not limited to, helmets and appropriate footwear.
3. **Medical Condition:** I certify that I am in good physical condition and do not have any medical conditions that would prevent me from safely participating in horseback riding activities. I agree to disclose any medical conditions or concerns to Our Red Barn Ranch, LLC prior to engaging in any activities.
4. **Release of Liability:** I hereby release, waive, discharge, and covenant not to sue Our Red Barn Ranch, LLC, its owners, employees, agents, and representatives from any and all liability, claims, demands, actions, or causes of action arising out of or related to any loss, damage, or injury, including death, that may be sustained by me while participating in horseback riding activities, whether caused by the negligence of Our Red Barn Ranch, LLC or otherwise.
5. **Indemnification:** I agree to indemnify and hold harmless Our Red Barn Ranch, LLC, its owners, employees, agents, and representatives from any and all claims, actions, suits, procedures, costs, expenses, damages, and liabilities, including attorney's fees arising out of or in any way related to my participation in horseback riding activities.
